CONDITIONS OF SALES AND RETURN POLICY:

1. Bookstore agrees to:
 - a. Make payment in the form of check, credit card (Visa, MC or AMEX only), or money order at time of order. Purchase orders *may be* accepted, if so, payment is due within 30 days from the date of invoice.
 - b. Provide TNA with Texas Sales Tax Resale Certificate (Texas Comptroller Form 01-339) at time of order or pay applicable sales tax.
 - c. Be responsible for collecting and remitting all applicable sales tax.
 - d. Assume title and risk of loss upon acceptance of the book(s). Damages, shortages or defective items must be reported immediately upon receipt. Claims made one (1) month following date on packing slip will not be honored.

2. Books are sold outright and not on consignment. Bookstore may not return books for either credit or refund, except as outlined in the following:
 - a. Bookstore may return defective or damaged-in-transit books for replacement or full credit within 30 days from date of packing slip.
 - b. Bookstore may return books within one hundred eighty (180) days from date of packing slip for credit or refund not exceeding twenty percent (20%) of the dollar value of the originating purchase order.
 - c. Bookstore is responsible for shipping charges on all book(s) returned.
